Please, I ask you to extend the terms of your commercial offer to all Organizations of the OAT group purchasing the identical goods, work or service.



2. Manufacturer: Jinzhou Leader Shock Absorber Co., Ltd.
3. Quality level PPM=0 upon delivery.
4. Conditions and terms of delivery of goods - delivery by the supplier.
 - 4.1. Provide a price without delivery, on FCA SAAZ Complecte LLC.
 - 4.2. Provide a price with delivery, on DDP terms.
5. Terms of payment - deferred payment for 45 days, obligatory provision of a calculation. The cost of packaging is included in the price.

II. Requirements to GWS¹ Supplier

1. Main requirements:
 - legal capacity, incorporation and registration in the prescribed manner;
 - compliance with the requirements established in accordance with the legislation of the Russian Federation for persons supplying goods, performing work, and providing services that are the subject of procurement;
 - failure to liquidate the legal entity and the absence of a decision of the arbitration court on declaring the legal entity, individual entrepreneur bankrupt and on opening of bankruptcy proceedings;
 - non-suspension of the counterparty's activities in the manner prescribed by the Code of Administrative Offenses of the Russian Federation on the day of filling an application in order to participate in procurement;
 - lack of information about the Supplier, including information about the founders, members of the collegial executive body, person acting as the sole executive body of the procurement participant - legal entity in the register of unscrupulous suppliers, provided for Art. 5 of Federal Law No.223-FZ and Federal Law No.44-FZ.
 - a person who is the head of a legal entity must not have a valid disqualification, restrictions on service or a ban on professional or other activities;
 - financial and business activities of a potential supplier should not pose the high tax risks for the company and / or be aimed at obtaining unjustified tax benefits;
 - registration as a procurement participant is carried out on OAT, LLC website www.oat-group.ru in the "Suppliers" section, either by registration on the electronic trading platform (or by sending requests to the email address indicated in the notice of procurement opening).
2. Additional requirements:

¹ GWS – goods, work, service

- the potential supplier must be the manufacturer, the official representative of the manufacturer, or dealer, subject to the submission of a document from the manufacturer of the goods or confirmation of the status of the dealer / distributor on the manufacturer's official website, in addition, the status is allowed:

- official system partner, intelligent solutions developer, when purchasing equipment, subject to the provision of a partnership / development document;
- partner / buyer, when purchasing non-transit norms of goods, or single norms, or goods discontinued (for example, for repair and maintenance needs, not serial delivery), provided that copies of the purchase and sale agreements with the manufacturer are provided.

- a potential supplier must have sufficient resources to fulfill obligations for the supply of goods, works and services;
- potential supplier should not be associated with other procurement participants. Associated procurement participants are understood to be procurement participants who are under direct or indirect control of the same individuals;
- no criminal proceedings have been instituted against a potential supplier, its founders and managers on the grounds related to production activities related to the subject of procurement, or of a corrupt nature;

All requirements for the procurement participant can also be established in the procurement documentation for co-contractors (subcontractors, subcontracting suppliers), involved by the procurement participant to execute the contract with the Customer. Responsibility for the compliance of all involved subcontractors (subcontractors, subcontracting suppliers), regardless of the volume of supplies, work, services performed by them, with the requirements specified in the procurement documentation, including the availability of permits for them, lies with the procurement participant.
